SPLIT ROCK BOAT SLIP RULES & REGULATIONS

- Boats must be legally authorized to operate in PA.
- Members must purchase a Split Rock Recreation Program (SRRP) in order to rent a boat slip. Personal Watercraft (e.g. Jet Skis) are **prohibited on Split Rock's owned docks and launch area.**
Only Members may use Split Rock's launch area and boat size/type limitations apply.
- **All boats have must have SR Slip Sticker and LH Sticker BEFORE allowed into the dock ramp - NO EXCEPTIONS (if you are having your boat dropped off - please pick up stickers ahead of time to give to your boat keeper)**
- 2009 stickers will be provided and must be affixed to the front hull of the boat on the land facing side.(i.e. bow facing cove – sticker on port (left) side; bow facing lodge – sticker on starboard (right) side.)
- **This application, copy of insurance, photo & copy of registration must be received before you will receive slip stickers**
- **Slips will not be held for anyone after March 15, 2010 if all information and payment is not received**
- **If you are requesting a new slip - there is a waiting list - you must be on the list - it then goes in order - and then by boat size. All information with check must be in before you are considered for a slip - Please send separate check with your application for your boat slip if you are applying for a new slip.**
- **Boats larger than 18 ft, Pontoon Boats and Jets ski are NOT permitted on Split Rock Docks - Largest Boat (18' Long - 100" wide - each dock has different dimensions and there are only a few that can accommodate 18' boats.**
- Only manufacturer approved gas tanks, normally to operate a boat, may be stored on a boat occupying a Split Rock slip. Our insurance coverage prohibits other gas containers from being stored on boats or other VCL property.
- **Boats can occupy dock AFTER May 7th, 2010 and must be removed by October 15, 2010.**
- Previous Slipholders have priority to renew slips for current year as long as they were in USE in prior year. New requests are considered in order of availability and slip size.
- **Members must have their (SRRM) form and full payment in by March 15, 2010.** If not received by this date, the slip may be released to another member.
- Members may be assigned 2 slips per season (e.g. motor boat and sailboat) if available and only after all other members requests have been satisfied. The member must designate which slip is "primary" and "secondary". The secondary slip will only be available to the member in the next season if it is not required as a primary slip for another member.
- Usage of the slip is required (even if it is paid for) and only boats owned by the cottage owner, as evidenced by the current boat registration, can occupy the slip, NOT relatives, friends, guests, etc.
- **Slips may be reassigned to accommodate boat size or for other reason at the sole discretion of VCL.**
- Only Members may use the launch area, subject to size and type exclusions above. Members who do not have a slip cannot tie up to any dock or lake front property owned by Split Rock.
- Fire regulations require certain docks to be cleared of gas powered boats during the **fireworks display** – which are scheduled for **July 3rd, 2010 with a rain date of July 5th, 2010.** Other dates may be identified in the future. Unless otherwise notified, docks A, B and Ski must be cleared from 8pm until after the display, approximately 10:30pm. It is the boat owners responsibility to comply with this requirement. If owner fails to comply, the boat will be moved solely at the owner's risk and expense.
- The PA Fish and Game Commission patrol and the Lake Harmony Group monitor the lake, please make sure that your boat meets all safety and operational requirements.
- Due to the limited dock space, slips are not available to owners who lease their property during the boating season.
- A sticker is now needed for Lake Harmony - you can purchase one of these stickers through Split Rock if you do not have a dock with us. If you do have a dock purchased from Split Rock Resort then your sticker will be included. **IF YOU HAVE YOUR OWN DOCK THEN YOU NEED TO PURCHASE A LAKE HARMONY GROUP STICKER FROM THEM - EITHER THROUGH SPLIT ROCK OR THROUGH THE LAKE HARMONY GROUP - EVERY MOTORIZED MOTORCRAFT MUST HAVE A STICKER/ SAILBOATS and other non-motorized boats do not need a sticker..**
